

**AMENDMENT**  
**TO**  
**THE MEMORANDUM OF UNDERSTANDING**  
**AMONG**  
**THE FOOD AND AGRICULTURE ORGANIZATION OF THE UNITED NATIONS**  
**(FAO),**  
**THE WORLD HEALTH ORGANIZATION (WHO),**  
**THE UNITED NATIONS CHILDREN'S FUND (UNICEF),**  
**AND**  
**THE UNITED NATIONS WORLD FOOD PROGRAMME (WFP)**  
**CONCERNING**  
**THE HOSTING AGREEMENT OF THE REACH PARTNERSHIP**  
**(hereinafter, individually, the "Party", and collectively, the "Parties")**

**WHEREAS** the Parties have entered into the Memorandum of Understanding concerning the Hosting Agreement of the Reach Partnership, dated 7 December 2011 (hereinafter, the "**MoU**");

**WHEREAS** the Parties concluded a Revalidation Agreement of the MoU, dated 5 November 2015, whereby the MoU was revalidated to remain in force from the date of its expiration on 7 December 2014 until 31 December 2017 (hereinafter, the "**Revalidation Agreement**");

**WHEREAS**, under the Revalidation Agreement, all provisions of the MoU shall continue to be effective until the date of expiration of the Revalidation Agreement, unless modified through the Revalidation Agreement or any formal future amendments;

**WHEREAS**, under Article VII, paragraph 7.8 of the MoU, any amendment to the MoU shall be effected by mutual agreement of the Parties through a written document affirming to be an amendment of the MoU; and


**WHEREAS** the Parties wish to extend the term of the MoU until 31 December 2018;

By concluding this Amendment (hereinafter, the “Amendment”), the Parties hereby agree as follows:


1. In amendment to Article VII, paragraph 7.2 of the MoU, the MoU shall remain in effect until 31 December 2018.
2. This Amendment shall be effective as of the date of last signature by the Parties.
3. This Amendment shall be an integral part of the MoU. Except to the extent specifically amended or superseded by the terms of this Amendment, all of the provisions of the MoU shall remain in full force and effect as of the effective date hereof. The MoU, as modified by this Amendment, constitutes the complete agreement between the Parties and supersedes any prior written or oral agreements, writings, communications or understandings of the Parties with respect to the subject-matter thereof. In the event of any conflict between the terms and conditions of this Amendment and the MoU, the terms of this Amendment shall prevail. This Amendment shall be taken as an Annex to the MoU.

IN WITNESS WHEREOF, the undersigned, duly authorized representatives of the Parties, have signed this Amendment on the dates specified below.


